### **What is C.O.M.O.N?**

I'm Debbie Schroeder and in addition to being Director-at-Large of Policy and Procedures I am your representative to THE Coalition of Michigan Organizations of Nursing (C.O.M.O.N). This organization is "dedicated to the advancement of Nursing in the State of Michigan. C.O.M.O.N's mission is to serve as a vehicle that gives all nurses the opportunity to collectively work together to achieve mutually agreed upon goals for Nursing in Michigan". Membership in C.O.M.O.N includes over 40 different nursing specialty organizations. Some examples are: MSGNA, Academy of Med/Surg Nurses, American assoc. of Critical Care Nurses, Michigan College of Nursing., Michigan Assoc. of CRNA'S. Michigan Board of Advanced Practice Nurses just to give you an idea.

The last meeting was March 19, 2015. We approved the changes to the bylaws which were very minimal. Also on the agenda was Bill # 2 which has been in the senate for 2 years waiting to be approved.

- SB 2 defines the scope of practice for APRNs and brings Michigan's Public Health Code (PHC) into alignment with national education and practice standards for three roles of APRN Practice (nurse practitioners, certified nurse midwives and clinical nurse specialists.)
- SB 2 allows for full prescriptive authority within the parameters of APRNs' education, training, and national certification. Licensure and prescriptive authority for qualified APRNs allows for better tracking of outcomes, increases billing transparency and clarifies accountability.

C.O.M.O.N is encouraging all Nurses to know who their representatives are and to write them in support of this Bill.

## ABCGN Recertification Program Changes

January 1, 2013, ABCGN begin implementing the following changes to its recertification program:

1. All recertification applications will need to be submitted using ABCGN's online recertification application.
2. ABCGN has added another category—Category 13: Involvement in other GI related organizations or publications--to help candidates amass the necessary contact hours.
3. Due to escalating operating expenses, ABCGN is increasing the recertification fees by \$50 (\$10 per year).

## **Online System**

The online system exactly mimics the paper application and is a quick and easy method to submit without the hassle and cost of mailing the paper application. It is also a convenient system for tracking contact hours over the five-year period.

As with the paper application, certificates and back-up documentation are not required with the initial submission. If randomly selected by ABCGN for audit, you will be contacted and asked to provide this additional documentation.

ABCGN staff is happy to assist you with this process. We know you will find it's much simpler to keep track of your hours within the online system, and a quick and convenient way to recertify.

## **Category 13**

In response to inquiries, ABCGN has decided to broaden the areas of study for the CGRN to maintain national certification. Category 13: Involvement in other GI related organizations or publications has been added. Two (2) contact hours per year will be awarded for involvement in these GI focused professional organizations as an officer, committee/task force member at the regional or national level or as an appointed publication editor/reviewer. Minimum GI specific hours granted will be 2, maximum 10.

## **Fee Increase**

With the economy still struggling, recertification makes all the sense in the world for 2013. Recertification reflects your ongoing commitment to gastroenterology nursing.

There have been significant changes in the recertification program over the past five years, including:

- Categories have been added.
- Modifications have been made in minimum/maximum requirements.
- Online systems implemented

All these enhancements were made with you, the CGRN, in mind, but they do come at a price. Beginning in 2013, the fee to recertify is increasing by \$50 or \$10 per year to \$350 for SGNA members (\$435 for non-members). This is the first increase in several years and is necessary to cover ABCGN's increasing expenses. For those of you who participate in the submit per year program, you will need to pay the extra \$10 only for the years you have remaining till recertification.

Beginning in 2015, ABCGN is excited to announce a new program: **Quest for Success**. This exclusive opportunity allows individuals to continue on their journey for CGRN certification. The **Quest for Success** program will grant exam participants a reduced rate to take the test again for a second time should their initial attempt prove to be unsuccessful.

Preparing to take the CGRN exam is a major commitment and personal investment. Making the choice to reach this important professional milestone is now easier, since the **Quest for Success** program allows you to sit for the exam a second time at a deeply discounted rate.

*How does it work?* First, CGRN hopefuls should sign up to take the 2015 Spring Exam which is offered the entire month of May. The registration window opens January 1 and runs through February 27. Following the testing results, exam candidates who did not pass the exam will be given an opportunity to sign up for the Fall 2015 exam at a 50% discounted rate. This one-time **ONLY** discount applies to the second consecutive exam sign up. The **Quest for Success** program allows for continuous study and encourages individuals to keep working towards their CGRN certification.

### SGNA Medical Aid Scholarship
